Application to become an authorised Mobius Institute MRT Instructor

In order to be authorised to teach Mobius Institute Maintenance Reliability Transformation (MRT) courses, instructors must be suitably qualified and experienced. Please refer to the criteria below and provide relevant details of your experience.

Qualification Requirements for Instructors

Instructors should meet the following qualification criteria:

To become an instructor for **Preparing for MRT**

- Must have completed ARP-A Training course in FULL
- Must have completed Solo Package for MRT in FULL
- Must be Certified in either ARP-A or ARP-E or ARP-L
- Must be Certified in Mastering MRT
- Must have an exam score of 80% or more for the Mastering MRT exam

To become an instructor for **Mastering MRT**

- Must have completed ARP-A & ARP-E Training course in FULL
- Must have completed Solo Package for MRT in FULL
- Must be certified in either ARP-E or ARP-L
- Must be Certified in Mastering MRT
- Must have an exam score of 80% or more for the Mastering MRT exam

In addition to the above, instructors should have experience training people in Condition Monitoring, Maintenance or Asset Reliability, and a minimum of 5 years work experience in Condition Monitoring, Maintenance or Asset Reliability (actively involved in working in a plant or consulting).

Instructors are also required to complete the instructor induction course provided to them upon approval.

If you have a Mobius Institute Student account, please **ensure** that you have updated your current work experience to your record for review upon submission of this application.

Approval Process for Instructors

Approval of instructors shall be at the discretion of Mobius Institute.

Following review of this application, approval may be granted or denied by Mobius Institute. The applicant will be informed in writing of the decision. Approval shall not be unreasonably denied.

Approval, if granted, is valid for a period of five (5) years.

Responsibilities of an Instructor

- a) be familiar with the Mobius Institute MRT training program;

- c) be able to communicate effectively both in writing and orally (through an interpreter if necessary) in the language of training;
- d) make impartial and non-discriminatory technical presentations;
- e) ensure that the integrity of Mobius Institute training materials is not compromised in any way;
- f) ensure that the delivery of training does not promote specific commercial products or services;
- g) provide and encourage students to complete course evaluation survey sent to them upon completion of the course for relevant feedback
- h) ensure that students sign a training course attendance sheet, and ensure this is uploaded to the appropriate course for review and approval.
- i) undergo an annual audit and correct any non-conformances in a timely fashion (as per audit guidelines).

Confidentiality

Except as required by Mobius Institute or by law, information gained in the course of training activities about a particular person shall not be disclosed to a third party without the written consent of that person. Where the law requires information to be disclosed to a third party, that person shall be informed of the information provided as permitted by the law.
