MIBoC certificate holders are not permitted to use the MIBoC Certified Analyst logo in any form other than that provided for that purpose by MIBoC, or in a manner expressly approved by MIBoC.

Inappropriate reference to, or misleading use of the MIBoC logo in publications, catalogues etc shall be addressed with corrective measures, such as the suspension or withdrawal of certification, publication of the infraction if warranted, and, if appropriate, additional legal action. The corrective measures shall be decided by the Certification Manager and/or the Scheme Committee.

Form and display of the MIBoC Certified Analyst logo

The MIBoC Certified Analyst logo may be used in the form shown in figures 1 to 13 above, provided:

- 1. it is used only by the individual holding the corresponding valid and current certification issued by MIBoC;
- 2. it is printed in either monochrome or in the colours shown above;
- 3. it is used on stamps or stationery, including printed or e-mail letterhead or signatures.

Penalties for the misuse of the MIBoC Certified Analyst logo

Reported cases of the misuse (including false claims) of the MIBoC Certified Analyst logo shall be reported to MIBoC as per *ED007 - Complaints/Appeals Procedure*. Penalties for misuse, decided by the Scheme Committee may include but not be limited to:

- withdrawal or suspension of the certificate, card &/or logo;
- removing the candidate's name from MIBoC's website list of certified individuals and removing their digital certificate, card & logo from MIBoC's digital certificate platform
- publication of the infraction if the misuse was in the public domain;
- additional legal action, if appropriate.
